Your Excellency,

It is with grave disappointment and righteous indignation that I, Sultan Abdul Al-Kabir, must once again address your willful neglect of my previous correspondences dated February 17, 2025, and March 11, 2025. The Empire of Morocco, a sovereign and independent State, has been met with silence and contempt from your administration. Political discourse affronts not only our nation but also the very principles of justice, decolonization, and human dignity enshrined in the United Nations Charter, UN Resolution 1514 (XV) of 1960, and the bilateral Treaties of Peace and Friendship of 1787 and 1836, inter alia.

The lower courts of the several Union states of the United States, in their continued detention of Moroccan nationals, are engaging in nothing short of colonialism and extraterritorial jurisdiction. These unlawful practices have long been condemned by international law since 1960. Any manifestation of colonial acts violates:

1. The peremptory norms of the UN Charter (Articles 1(2), 55, 73, and 74) mandate the speedy end of colonial subjugation and clearly promote the recognition of self-determination.
2. UN Resolution 1514 (XV) declares that "all people have the right to self-determination" and that "immediate steps shall be taken to transfer all powers to the peoples of non-self-governing territories."
3. The Madrid Convention of 1880 and the Act of Algeciras of 1906 affirm the Empire of Morocco's sovereignty and the inviolability of its nationals from foreign extraterritorial judicial overreach.

4. The Treaty of Peace and Friendship of 1787 and 1836 binds the United States of America, the United States, and its several states to respect Moroccan sovereignty and the Sultan's authority over Moorish subjects, proteges, and Moroccan nationals.

Your colonial American courts' refusal to release Moroccan nationals, many of whom are duly elected or appointed officials of the Empire, constitutes crimes against humanity under international law and Moroccan law. Moroccan nationals are protected by sovereign immunity, and their unlawful detention is a brazen violation of diplomatic and consular norms.

### Final Notice of Escalation

Since your administration has chosen to ignore my friendly application and demands, the following actions will now be taken for redress:

1. Consul Generals of the Empire of Morocco and its Moorish government will formally seek civil or criminal suits in the Consular Court with the organs of your U.S. State Department and the organs of the several Union states who violated and continue to violate Moroccan law, international law, and human rights.
2. Should the United States ignore the Orders and Judgments of the competent Moorish Consular Courts (MCC), the Empire of Morocco will petition the International Court of Justice (ICJ) to seek redress, citing your violations of the Moroccan-American treaty obligations and human rights.

### Immediate Demand for Compliance

The following Moroccan nationals must be released immediately into the custody of their respective Consul Generals by April 30, 2025:

As stated above, this is not a request. This diplomatic letter shall serve as a lawful decree under the authority of the office of the Sultan and the Empire of Morocco. Failure to comply will result in irreparable damage to diplomatic relations and expose the United States of America et al. to international condemnation and further legal consequences. The world is watching. History will accurately record your actions or inaction, either in compliance with justice or complicity in colonial subjection and oppression.
